

Talents from the Airport 2019 **Terms and Conditions**

1. Introduction

- a. The 'Talents from the Airport 2019' ("the Competition") is organized by the Airport Authority Hong Kong (the "Organizer");
- b. The competition is composed of, i. Application submission, ii. Audition and iii. Final Competition; Family and Kids Performance will be featured on the Final Competition.
- c. Airport community staff are invited to participate as Contestants; and
- d. Different forms of talent/performance are eligible for the contest. The Contestants hereby agree to participate in the Competition under the following terms and conditions.

2. Performance

- a. All performances should not contain any fire, explosive, corrosive, irritating, hazardous materials, toxic chemical, create danger to both performer or any person, nudity, obscene languages, inappropriate setting or may cause any disturbance to audience, etc; and
- b. Airport Authority has final right to prohibit any acts from performing at any time during the event period without any compensation to the performer

3. Eligibility

- a. The Contestants must be a current employee or employees in airport community who work at the Hong Kong International Airport or on Chek Lap Kok Airport Island during the whole event period; and
- b. The Contestant(s) can be one person or in a group.

4. Entry Method

- a. The Contestants must complete and sign the Application Form and submit the application form to the Organizer on or before **11:59pm of 8 May 2019** to the e-mail: hkiarace@hkgairport.com or fax to 2182 3136;
- b. Contestants will receive an e-mail confirmation after the application form has been received by the Organizer; and
- c. Late submission and incomplete Application Forms will not be accepted.

5. Audition

- a. Contestants will receive an e-mail notification for the audition on or before 9 May 2019;
- b. Audition will take place on 14 May 2019 and 15 May 2019 (between 9:00am – 6:00pm) at Moscow & Ottawa Suites Basement, Regal Airport Hotel.
- c. Contestants will be notified of their assigned time slot via email;
- d. Failure to show up punctually at the assigned time slot session will be disqualified;
- e. Performance time cannot exceed 5 minutes for each Contestants or team.
- f. Contestants must prepare their props/tools/gadget/background music (in the format of MP3 saved in USB flash drive) for the audition.
- g. Scores will be given by a judging panel comprised of the Organizer's representatives; and
- h. The top 9 Contestants from the audition will enter the Final Contest.

6. Final Contest

- a. Qualified contestants will receive an e-mail notification for the Final Competition on or before 17 May 2019.
- b. The Final Competition will take place from 2:30pm – 5:30pm on 25 May 2019 (Sat) at Gordon Wu Hall, BP International, 8 Austin Road, Tsim Sha Tsui.
- c. Rehearsal will take place at the venue from 10:00am – 1:00pm on 25 May 2019 (Sat).
- d. Contestants must prepare their props/tool/gadget/background music (in the format of MP3 saved in USB flash drive) for the Final Contest.
- e. The Judging Panel will be comprised of the Organizer's representatives, a professional artist and other stakeholders of the Contest; and
- f. Failure to show up punctually at the assigned Final session will be disqualified from the Contest.

7. Prize

- a. Prize redemption – all prize winners must retain their status as an airport community employee when redeeming their prizes. Fail to provide supporting information on the current employee status (as a current airport community employee) may result of prize suspension; and
- b. Prize winner is required to redeem on or before 31st July 2019.
- c. The Organizer has the discretion to bestow any prizes on any Contestant.

8. Family & Kids Performance

- a. All applicants who applied Family & Kids Performance will be given a particular time for the performance on the Final Competition
- b. "Family & Kids Talents Awards" will be presented with the Family & Kids Performance. The award will be selected by the Judging Panel of the Final Competition.
- c. If organizer received overwhelming response, the organizer will consider whether to have audition for the Family & Kids Performance or not. If audition is needed, further notice will be given.
- d. Different forms of talent/performance are eligible for the Family & Kids Performance, but should be restricted to Point 2 "Performance" under this terms and conditions

9. Acknowledgement

- a. The Contestants hereby acknowledge and agree that the Organizer may in its absolute discretion:
 - i. Reject or withdraw any Contestant(s);
 - ii. Select any of the Contestant(s) to participate in the Audition; and
 - iii. Bring forward, postpone or cancel scheduled date(s) or change the designated venue for the Audition, and the Final Contest.
- b. The Contestants further acknowledge and agree that:
 - i. The materials (i.e. USB flash driver, DVD or any other format) submitted to the Organizer will not be returned to the Contestant(s);
 - ii. The Organizer shall not be liable under any circumstances for any loss or damage including personal injury or death of Contestant(s) during the Contest;
 - iii. The Contestants shall abide by the decision of the Organizer and that of panel judges at the Audition and the Final Contest;

- iv. Performances in the audition and Final Competition or any other appropriate circumstances will be filming and recording. The Contestants understand and agree that the Organizer will use their names, photos and videos both in print and online format or share with other media channels for publicity and promotions; and
 - v. The Contestants grant the Organizer the right to use the submitted photos, including but not limited to copy, reproduction or publication, in any media channel, for promotional or any other purposes without further consent or any payments. The Contestants agree that the Organizer has the absolute right to edit or alter any of the materials submitted for the Contest.
10. The Organizer reserves all rights to amend the relevant rules of the Audition and the Final Competition without prior notice.
11. Language
- a. The Terms and Conditions and the Application Form are in both English and Chinese. The Contestants understand that the Chinese translation is for reference only and in the event of any conflicts between the versions, the English ones shall prevail.
12. Law
- a. These Terms and Conditions will be subject to the laws of Hong Kong.
13. Nothing contained in this Terms and Conditions shall constitute a partnership or contract of employment between the Organizer and the Contestants.
