COVID-19 Vaccination Free Air Ticket Lucky Draw to Airport Community Terms and Conditions

<u>General</u>

1. By participating in the draw, each individual ("Participant") confirms that he/she has read the Personal Information Collection Statement and Privacy Pilicy and agreed to these terms and conditions before registering for this Lucky Draw or providing their personal data to his/her Entity Representative s (as defined below).

Eligibility

- 2. Subject to Clause 3, this Lucky Draw is only open to individuals who fulfill all of the following requirements:
 - (a) he/she is a permanent or non-permanent Hong Kong resident holding a valid Hong Kong Identity Card; and
 - (b) he/she possesses either:
 - (i) a valid Airport Staff Octopus card; or
 - (ii) a valid Airport Restricted Area (ARA) Permit; or
 - (iii) a valid Tenant Restricted Area (TRA) Permit; or
 - (iv) a valid staff card issued by an entity or company having operations at the Hong Kong International Airport ("**HKIA**", which includes newly reclaimed land as part of the expanded Chek Lap Kok island); and
 - (c) he/she is, until 30 September 2021, employed by one of the following entities or companies, whether on a full time, part time or casual basis:
 - (i) the HKSAR Government;
 - (ii) the Airport Authority ("AA");
 - (iii) any statutory body having operations at HKIA;
 - (iv) any company having business operations at HKIA, irrespective of whether or not that company has a direct contractual relationship with AA;
 - (d) having worked at HKIA for not less than 3 working days a week within the last 4 weeks of 1 September 2021 (Wednesday); and

(e) he/she has or shall have received two doses* of the COVID-19 vaccines under the COVID-19 Vaccination Programme implemented by the HKSAR Government on or before 30 September 2021. Both doses of the respective vaccines must be received in Hong Kong.

*Persons previously infected with COVID-19 are also eligible after having received one dose of COVID-19 vaccine in Hong Kong under the COVID-19 Vaccination Programme implemented by the HKSAR Government before 30 September 2021 if they meet all other conditions stated above.

3. Staff members of Airport Authority (AA), Cathay Pacific (CX), HK Express (UO) and their agencies / contractors who have direct involvement in the design, organisation, execution, promotion or administration the Lucky Draw are not eligible to participate in this Lucky Draw.

Registration

- 4. Each Participant shall register the draw through his/her entity representative ("Entity Representative"). A Entity Representative is a representative nominated by an entity listed in Clause 2(b), who may or may not be the head of the Human Resource Department of that entity.
- 5. A Participant shall only register for this Lucky Draw once through his/her Entity Representative . Any duplicated registration will be disregarded. AA reserves the rights to remove any duplicated entries.
- 6. Entity Representative will not able to make changes to any after submission. All information is based on the online registration records, any incorrect or incomplete information may result in a Participant's disqualification in this Lucky Draw.
- 7. Registration for the Lucky Draw will commence on 1 September 2021 and will close on 30 September 2021 at 11:59 p.m. (Hong Kong Time).

Reference Number

- 8. Upon successful registration, each Participant will receive by email to the email address provided at registration with one reference number which represents his/her one chance for drawing in the Lucky Draw.
- 9. In addition, a Entity Representative will receive an email with a list of Participants of his/her own entity and the reference numbers of each of the Participants in his/her own entity.

10. The reference number is assigned by computer system to a Participant and is non-transferable.

Responsibilities of Each Participant

- 11. Each Participant shall ensure that:
 - (a) fulfills all the requirements as set out in Clause 2;
 - (b) he/she has read the Personal Information Collection Statement and Privacy Policy;
 - (c) he/she has agreed to these Terms and Conditions;
 - (d) he/she has selected a preferred destination group, the destination awarded will be one of the destinations within his/her selected preferred destination group, details of each destination group are listed as follows:
 - Group A Mainland, Taiwan, Japan, South Korea
 - Group B Southeast Asia Destinations
 - Group C Long-haul Destinations
 - Group D Any of the above

- (e) he/she has provided true and accurate personal data to his/her Entity Representative (defined in Clause 4) for registration of this Lucky Draw;
- (f) Participants will be disqualified if any submitted personal data is inaccurate or incomplete.

Responsibilities of Entity Representatives

- 12. Each Entity Representative shall, on behalf of the Participants of his/her entity:
 - (a) gather the personal data of each Participant of his/her entity and input the same in the e-form provided at Lucky Draw website at https://hkiacommunityvaccinationluckydraw.com;
 - (b) register, on behalf of the Participants of his/her entity, by uploading the completed e-form onto the Lucky Draw website at https://hkiacommunityvaccinationluckydraw.com.
- 13. Each Entity Representative is responsible for ensuring:
 - (a) each Participant fulfills all the requirements as set out in Clause 2;
 - (b) each Participant of his/her entity has read and agreed to these Terms and Conditions and the Personal Information Collection Statement;
 - (c) ensuring the personal data to be submitted to the Lucky Draw website is accurate.

Announcement of results

- 14. Winners will be randomly drawn on 4 October 2021 (Monday) by the computer system.
- 15. The reference number of winners of the Lucky Draw will be published on the HKIARaCE website (https://extranet.hongkongairport.com/HKIARaCE/mega-event-en.html), and the Lucky Draw website (http://hkiacommunityvaccinationluckydraw.com). In addition, result of Lucky Draw will be published on 2 local newspapers, The South China Morning Post and Oriental Daily News, on 5 October 2021 (Tuesday).
- 16. All winners will be notified individually by email to the email address provided at registration. Their respective Entity Representative will also be notified by a separate email to the entity.

Participants who do not receive any notification shall regard themselves as having lost on the Lucky Draw.

- 17. Irrespective of the number of lucky draws that a Participant participants in, each winner is entitled to win only one free air ticket in all lucky draw campaigns that are sponsored by AA in supporting the COVID-19 Vaccination Programme as implemented by the Hong Kong Government, including this lucky draw, and other lucky draws for giving away air tickets to employees of AA and Hong Kong residents, including:

Prizes

- 18. All prizes are air tickets ("**Prize Tickets**") and are non-transferable, redeemable for cash or other gifts.
- 19. A total of 10,000 prizes will be given out to 10,000 winners as follows:
 - (a) Cathay Pacific ("**CX**") air tickets: Each winner shall be given ONE (1) complimentary round-trip Economy Class ticket from Hong Kong to a destination (Total: 5,000 Prize Tickets) provided by CX.
 - (b) HK Express ("**UO**") air tickets: Each-winner shall be given ONE (1) complimentary round-trip Economy Class ticket from Hong Kong to a destination (Total: 5,000 Prize Tickets) provided by UO.
- 20. All Prize Tickets are exclusive of airport taxes, airport security charges, fuel surcharges, additional baggage fees, insurance fees, any other fees. Winners are responsible for payment of these charges.
- 21. Airport Authority may, without giving notice or reason, at any time disqualify any Participant or winner who, in the reasonable opinion of the Authority:

- (a) tampers with the operation of the Lucky Draw;

Disputes
